In 2015 (as of 1st January 2015), the number of co-operatives in Thailand were 8,173 which can be classified into active


and non-active co-operatives. The active co-operatives are those in ready-for operation and in-operation status.

6,998 of which were in-operation and 221 of which were ready-for operation.





Figure 3 trend of co-operative memberships from 2006 - 2015




